### HEALTH HAZARD INFORMATION

#### Acute:

**Swallowed:** Short-term exposure by ingestion is considered to be practically non-hazardous.

**Eye:** May cause mild aggravation.

**Skin:** May cause dryness by defatting.

**Inhaled:** Not applicable.

#### Chronic

Should an unfavourable skin reaction occur, discontinue use until condition subsides. Regular use of a barrier cream is recommended in such cases.

#### FIRST AID

**Swallowed:** Contact a Doctor or Poisons Information Centre. **PROMEDICAL 115 or 25566 or Vila Central Hospital 112.**

Do NOT induce vomiting. If the patient is not fully conscious do not give anything by mouth.

**Eye:** Wash with water.

**Skin:** Wash with water.

**Inhaled:** Leave contaminated area.

**FIRST AID FACILITIES:** Eye wash. Fresh water.

**ADVICE TO DOCTOR:** Neutral detergent.

### PRECAUTIONS FOR USE

**Exposure Standards:** No exposure standard is assigned for any hazardous ingredients.

**Engineering Controls:** When used according to directions there is no special ventilation requirement.

**Personal Protection:** Minimise contact of undiluted product with the skin and eyes. Wearing gloves such as rubber or neoprene when using the undiluted product may be required for people with sensitive skin.

**Flammability:** Flash point between 23 and 61°C, but "aqueous solutions containing not more than 24% ethanol by volume are not considered to be dangerous goods of Class 3."

### SAFE HANDLING INFORMATION

**Storage and Transport:** No special precautions.

**Spills and Disposal:** May be flushed to sewer with water but prevent larger spillages from entering storm-water drains or water courses. To contain spillage, absorb on vermiculite or similar absorbing material and collect in drums. Residues may be flushed away with water.

**Fire/Explosion Hazard:** Use water fog, foam or dry agent. Danger of violent reaction or explosion. Wear breathing apparatus and protective gloves for fire only. Dilute. Wash to drain with large quantities of water. Consider evacuation.
